Comrades,

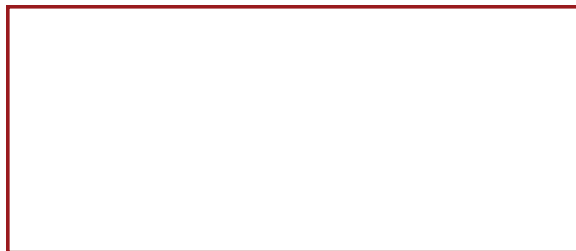

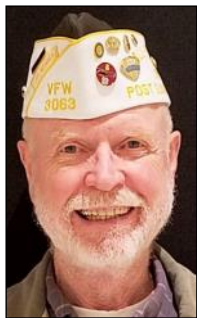

## Zoom Meeting Details for April 2 Business Meeting

The post business meeting scheduled Thursday, April 2 at 7 p.m. will be conducted via Zoom videoconference. **Here are the Zoom download and connection directions:**

- Go to <https://zoom.us/download> and select “Zoom Client for Meetings” to download Zoom for your computer or “Zoom Mobile Apps” to download Zoom for your phone.
- At 6:50 pm Thursday, April 2, click on this meeting link (or in the email sent out by Adjutant Teeter): <https://zoom.us/j/5057012075>.
- A new Zoom window will open and then, inside, another smaller window will open with a box that says, “Open Zoom meetings.” Click on that box to join the meeting.
- If a dialogue box appears that says “Join with computer audio” click on that.
- Once you have joined you will see all the other participants.
- Once the meeting starts, you will be able to hear the officers but all other participants will be muted.
- If you have a question or want to make a motion, etc., click on the small hand icon in the lower right part of the screen. A raised hand will appear on your picture and the commander or quartermaster will unmute and call on you. After you make your motion or ask your question you will be muted again.
- NOTE: If you are connecting on a desktop, laptop or tablet and have decent WiFi, you should have no problem. If you are connecting with a smartphone, you may have trouble seeing the video but should have no trouble hearing the audio.

- Boat shows, markets, fairs, etc. Always have a service officer present. Bring prospect forms so you can contact them again to join.
- Challenge post members to recruit at least 1 new member a year.

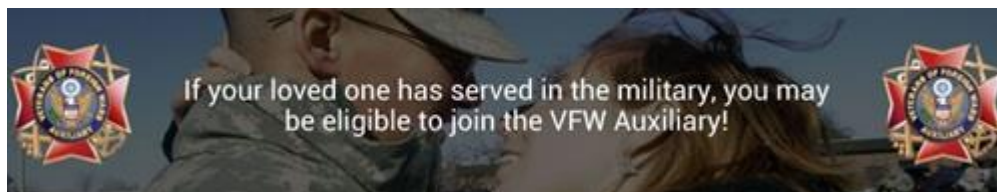
