Howard Rutledge* tells about his plane being shot down over Vietnam. He parachuted into a little village, where he was attacked, stripped naked and imprisoned.


For the next seven years, he endured brutal treatment, sometimes shackled in excruciating positions and left for days in his own waste. Rats the size of cats crawled around his cell. Later, he wrote a book about his ordeal and gave a powerful testimony as to the importance of Scripture.

He goes on to say, "I would pray, hum hymns silently, quote Scripture and think about what that verse meant to me...the enemy knew that the best way to break a man's resistance was to crush his spirit in a lonely cell." The former POW states, "Scripture and hymns might be boring to some, but it was the way we conquered our enemy and overcame the power of death around us." [Bill Griffith]

VFW National Convention

Our national convention is the governing body of the Veterans of Foreign Wars. Every year we meet to decide on changes to our By-Laws and Ritual, set policy and elect leaders for the ensuing year. We also hear from various dignitaries perhaps including the local mayor and governor, senators and representatives, the head of the Veterans Administration and the President or his designated representative.

This year the convention was convened in Pittsburgh and we heard from the Mayor of Pittsburgh, Bill Peduto; Pennsylvania Governor, Tom Wolf; Director of the VA, Robert McDonald and President Obama.

All things take time and eventually an organization has to change to survive. We did and we will.

Mayor's Meeting On Homeless

On August 12, from 6:30 to 8:00 PM, the Mayor's office held a meeting for Ballard residents and other interested parties concerned with the abrupt announcement of the establishment of a tent city for homeless individuals at 2826 NW Market St. The doors of the Leif Erikson Hall opened at 6:00 PM. A standing-room only crowd (with more people waiting outside the door and others turned away) attended. Shortly after the doors opened, to establish the tone of the meeting, City staff started a Microsoft PowerPoint slide show, which continued on a loop through the full course of the meeting. The show consisted of very professional portrait type photos with first name captions of what presumably were very presentable homeless individuals.

The Deputy Mayor opened the meeting and made some brief remarks, followed by various City staffers. At 7:00 pm, comments from the audience began with the Deputy Mayor calling out names from signup sheets. As people entered, they were offered alternative sign up sheets labeled "against," "neutral" or "for."

Comments from the public were limited to two minutes, There was no evidence that a strict rotation from one list to another was used. Sometimes three speakers in a row offered support for the camp and at other times the same thing happened with those against the location. The very last speakers, at approximately six minutes before the meeting ended (presumably by coincidence) were three strong supporters of tent cities. Two clergy from different churches extolled the virtues and civil behavior of encampment residents. A final Ballard resident fervently wished the homeless camp could be located in a small park across the street from his house because they made such good neighbors.

From applause and boos, it seemed to this observer the majority of the audience opposed the location and resented the lack of communication and involvement with the city process. Speakers from the side in favor focused their comments on the importance of dealing with the homeless and the benefits of tent cities, largely ignoring the issue of the camp's location.

Our VFW Parking Lot

Many of you know about the proposed homeless encampment that is scheduled to go in on the lot next to our parking lot. As of this writing we still aren't sure of the outcome but we believe it is prudent to expect the camp to go in despite our (and our neighbors') well reasoned arguments to the contrary.

Even if the camp isn't placed on the Seattle City Light lot next to our parking lot we expect increasing problems with unauthorized persons parking in our lot. This end of Ballard is becoming more and more densely settled with even more construction scheduled.

In the past we have posted signs and towed the occasional violator but it is getting more difficult to manage parking in our lot. To help solve this problem we have made the difficult decision to place chains across the front of the lot. In addition we are asking that our members and other authorized users of our parking lot pick up a VFW card or decal from the office and display that card on the dash or place the decal on a window of your vehicle. This will help us identify authorized vehicles and initiate towing requests for the others.

The center chain will have two locks. One will be for Waste Management to open when they come in for our garbage, recycle and compost. The other will be a combination lock that can be opened by our members and other authorized users of the lot. When you stop by the office to pick up your VFW sign be sure to ask for the lock combination if you want to park in the lot at times other than regular meetings.

On meeting days, the parking lot will be open but if you open the chain at other times be sure to close it behind you. The combination must be moved before the lock will stay closed. I know this is an inconvenience but it has become necessary.

Proposed Homeless Encampment



"SUBJECT: City identifies public lands for permitted encampment sites

FOR IMMEDIATE RELEASE: 6/29/2015 4:00:00 PM

SEATTLE - Today Mayor Ed Murray released a <u>map</u> of City-owned properties most suitable for new permitted encampments to serve at least 200 individuals experiencing homelessness."

One of the proposed sites is 2826 NW Market Street (next to our parking lot) for approximately 52 residents.

Then the <u>Ballard Chamber of Commerce</u> and an ad hoc group called <u>Speak Up Ballard</u> got involved.. "The 90-day site review and selection process for this particular location was conducted secretly, with <u>absolutely no ad-</u> <u>vance notice or outreach</u> to our community's residents, businesses and property owners." "The Seattle City Council is refusing to consider citizen, neighbor and small-business owners concerns about the locations of new, city-sponsored homeless encampments in Ballard and other neighborhoods. This follows a cloaked site selection process that excluded public comment and provided no neighborhood notification." [Speak Up Ballard Petition, 1520 signers as of 8/23/2015]
